

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made and entered into as of the 30 day of April of the year 2025,

by and between:

The First Part (A):

Mrs Helen Guaci bearer of ID: [REDACTED] who is residing at [REDACTED] Gharghur, Malta, acting as the organiser of "Pjazza De Box" Gharghur Part 2, under the auspices of the MJBA.

and

The Second Part (B):

[REDACTED] bearer of ID: [REDACTED] who is the residing at [REDACTED], Malta, acting as the Co-Owner and Managing Director of [REDACTED] a boxing promotional group.

Article 1: Introduction and Purpose

The purpose of this MOU is to establish and formalize the financial agreement between Party A and Party B regarding the payment of EUR 400 per month, amounting to a total of EUR 23,500.00, to be paid on the last working Friday of each month. This sum represents the outstanding amount promised to pay for the expenses incurred by [REDACTED] in relation to Pjazza De Box - Gharghur Part 2

Article 2: Terms of this agreement

- a. Payment Amount: Party A agrees to pay Party B the sum of EUR 400 per month.
- b. Payment Schedule: Payments will be made on the last working Friday of each month until the total agreed amount of EUR 23,500.00 is fulfilled.
- c. Recipient: Payments are to be made to [REDACTED], Managing Director of [REDACTED] Entertainment.

Article 3: The Duration

This agreement will remain in effect until the full amount of EUR 23,500.00 has been paid in accordance with the schedule outlined above.

Article 4: Privacy & Confidentiality

All parties agree to maintain the **strictest of confidentiality** of any **proprietary & operational strategies** and other **information shared** during the course of this collaboration.

Article 5: General Provisions


- This MOU is binding and serves as a framework for the agreed financial arrangement.

Article 6: Governing Laws


Should the Parties not reach an amicable agreement arising from any disputes, this MOU shall be governed by and construed in accordance with the laws of the Republic of Malta.
